The Lamesa Area Chamber of Commerce reserves the right to select vendors whom in their opinion embrace the area wide community festival spirit. We also reserve the right to lift a vendor’s permit for any actions contrary to the spirit of the festival at any time before or during the festival. In such a case, the Lamesa Area Chamber of Commerce will not be responsible for any loss of revenue or fees. Decisions made by the Lamesa Area Chamber of Commerce regarding participation is final.

Returned checks will have a \$25 processing fee. Vendor must then pay via a money order or cash.
